

Data Privacy Statement

Scope of Application

This data privacy notice explains to users the nature, scope and purposes of the gathering and use of personal data by the provider responsible (Allocare AG, Kantonsstrasse 3, 6246 Altishofen) on this website.

Access Data / Server Log Files

The provider gathers data each time that this website is accessed (so-called server log files). The access data include:

- The name of the website accessed, file(s)
- The date and time of access
- The volume of data transmitted
- A notification about successful access
- The browser type and version
- The user's operating system
- The referring URL (the page visited previously)
- The IP address and requesting provider

The provider only uses the log data for statistical evaluations for the purpose of the operation, security and optimization of the website. The provider reserves the right to check the log data retrospectively if, based on concrete evidence, a justified suspicion of illegitimate use exists.

Dealing with Personal Data

Personal data is information, with the aid of which a person can be identified, i.e. details that can be traced back to a person. The latter includes the name, e-mail address or telephone number. However, personal data also includes data on preferences, hobbies, memberships or which websites have been looked at by somebody.

Personal data is only gathered, used and passed on by the provider if it is statutorily permitted or the users consent to the data being gathered.

Making Contact

When contact is made with the provider (for example, via the contact form or e-mail) the user's details are saved for the purpose of processing the enquiry, as well as in case any subsequent questions arise.

Newsletter

With the newsletter (e.g. release information) we inform you about ourselves and our products.

If you would like to receive the newsletter, we need a valid e-mail address from you, as well as information that allows us to check that you are the owner of the e-mail address given or that the owner of it is in agreement with receiving the newsletter. No further data is gathered. This data is only used to send the newsletter, and is not passed on to third parties. When you subscribe to the newsletter, we save your e-mail address and the date of subscription. You may revoke your consent to the storage of data, the e-mail address and the use of it for sending the newsletter. The revocation may be effected by sending us a notification, using any one of the above-mentioned contact options.

Integration of Services and Content of Third Parties

It may occur, that content of third parties, such as videos from YouTube, map material from Google Maps, RSS feeds or graphics from other websites are integrated into this website. This always requires the providers of such content (hereinafter referred to as "third party providers") to make use of the user's IP address. For, without the IP address, they would not be able to send the content to the browser of the respective user. The IP address is therefore necessary for displaying such content. We endeavor to only use content, for which the respective providers only use the IP address to deliver said content. We do not, however, have any influence upon whether the third party providers save the IP address, e.g. for statistical purposes. In so far as we are aware of this, we make this clear to the users.

Cookies

Cookies are small files which make it possible to save specific, device-related information on the user's access device (PC, smartphone, etc.). Firstly, they serve the purpose of making websites user-friendly, and thus making the users happy (e.g. by saving login data). Secondly, they serve to record the statistical data regarding website use, so as to be able to analyze it for the purpose of improving the website. The users may have an influence upon the deployment of the cookies. Most browsers have an option with which the storage of cookies is restricted or prevented entirely. It is, however, pointed out that the use, and in particular the convenience of use, is limited without cookies.
